At December 31, 2013, it managed 12 residential apartment buildings, having ownership of seven and partial ownership of five others through limited partnerships and limited liability companies. These buildings provide 425 units of low-income housing in Bellevue, Kirkland, Mercer Island, Redmond and Issaquah, Washington. In May 2012, the Organization purchased land with the intent of developing Totem Lake Phase II, a proposed 76-unit affordable housing development located in Kirkland, Washington.
